## Addendum Number 3 Invitation to Bid 18-22-206636 2-1/2 Ton Mechanical Boom Truck

SHIP CREEK AVENUE, ANCHORAGE AK 99501 UNTIL 3:00 PM LOCAL TIME ON, JANUARY 24, 2019 AT WHICH TIME BIDS WILL BE PUBLICLY OPENED.

## **PROPOSAL INFORMATION, CONDITIONS & INSTRUCTIONS:**

Closing date changed to January 24<sup>th</sup>, 2019.

## **BIDDER QUESTIONS:**

- 1. EXTERIOR A skid package is not available. This is typical for a 1-ton truck spec. *Please disregard this requirement*
- 2. INTERIOR Will you please provide clarity on the seats. Does only the driver seat need to be air ride? *Cloth Air Ride Driver with Inboard Armrest, Cloth Air Ride Front Passenger with Inboard Armrest, Cloth Non-Suspension Rear 3-man passenger*
- 3. ENGINE I would advise requiring a Fan Override Switch. This will keep the engine from overheating when the truck is in reverse going 22 MPH at max 2400 RPM. It's a very low price option, but will save hassle in overheating engine on long runs. *A Fan Override Switch shall be required by ARRC*
- 4. WARRANTY Extended warranties can be very expensive, so you will want to be very specific to what you need and want. Based on the engine and powertrain, you're asking for 5 years / 250K miles. Warranties are all "whichever comes first" policies. Therefore, you're implying that this truck will drive 50,000 miles per year. If that's the case, the 3 years / 36,000 miles basic bumper to bumper will expire in the very first year. Therefore, if you plan on going 50,000 miles per year, and you want a 3 year bumper to bumper warranty, I would suggest requesting a 3 years / 150,000 miles BTB warranty. However, if you don't expect the truck to drive 50K miles per year,

would reduce the mileage requirement for the engine and powertrain. All warranties come in increments of 50,000 miles, so there's no use in paying for the extra miles if the truck won't operate as such. Lastly, Cummins offer three (3) 5 years/ 250K mile (or whichever mileage you select) warranties as described below. Please select the one you would like so that all interested parties will bid the same. I've listed them in order of price. I have also attached a brochure that describes in detail what is covered.

o Protection Plan 2 – Major Engine Components excluding Turbo, Injectors, Electronics and Other Components

o Protection Plan 1 – Complete Engine including Turbo, Injectors, Electronics

o Protection Plan 1 with Aftertreatment – All of Protection Plan 1 plus SCR Assembly, DPF Assembly & Other AT Components

ARRC requires at least a 3 year/36,000 mile bumper to bumper warranty. ARRC also requires at least a 5 year/250,000 mile powertrain warranty. The powertrain warranty shall be equivalent, or exceed, the Protection Plan 1 with Aftertreatment coverage detailed in Cummins 2017 Extended Coverage Terms.
