Both the specifications and addendum questions 2, 21, & 24 ask for clarification as to the specific location of the Geogrid and Geoweb. Since they are not apparent on the drawings, then please confirm that they are not required for this project at any location. If they are, please indicate where they are specifically located at.

2. Pay item quantities 603, 611 for the 12", 18" and 24" CMP do not match to the corresponding estimated quantities on sheet 2 of 12. If the pay item quantity is correct, exactly where are all the pay item quantities located on the drawings?
