## **CLARIFICATIONS – APPENDIX F, SPECIAL CONDITIONS:**

Appendix F; Item Number 7 & Item Number 8: Pricing for line Item No. 8 will no longer be considered in the bid selection process. Pricing is still to be provided for VEP (line No. 7). The Contractor will be expected to coordinate with the Owner to develop the most cost effective and advantageous repair methodology for the outlined task. Upon review, approval and acceptance of the design and construction methodologies as proposed in the VEP, the Owner and contractor may proceed to negotiate on unit pricing for the implementation of the repairs as outlined in the VEP. If agreeable terms and pricing cannot be reached, the Owner may elect to perform the work in accordance with subsection 109-1.05 COMPENSATION FOR EXTRA WORK ON TIME AND MATERIALS BASIS. At any time, the Owner may elect not to perform the repairs, or any part of the repairs by removing them from the scope of this contract.

Appendix F; Item Number 6 and Item Number 4 (Basis of Payment): Applications for payment on Line Item Number 6 (Construction Survey) shall compensate the contractor for all required survey work on the project, including requirements outlined on separate project line items such as discussed herein. All contractors' construction survey cost / profit and their associated applications for payment shall concede with the percentage complete for the subsidiary pay items, including but not limited to *Line Item Number 4* (panel leveling). The contractors pay estimate for Construction Survey shall outline the percentage of work complete for the associative line item for which the construction survey work was performed.
