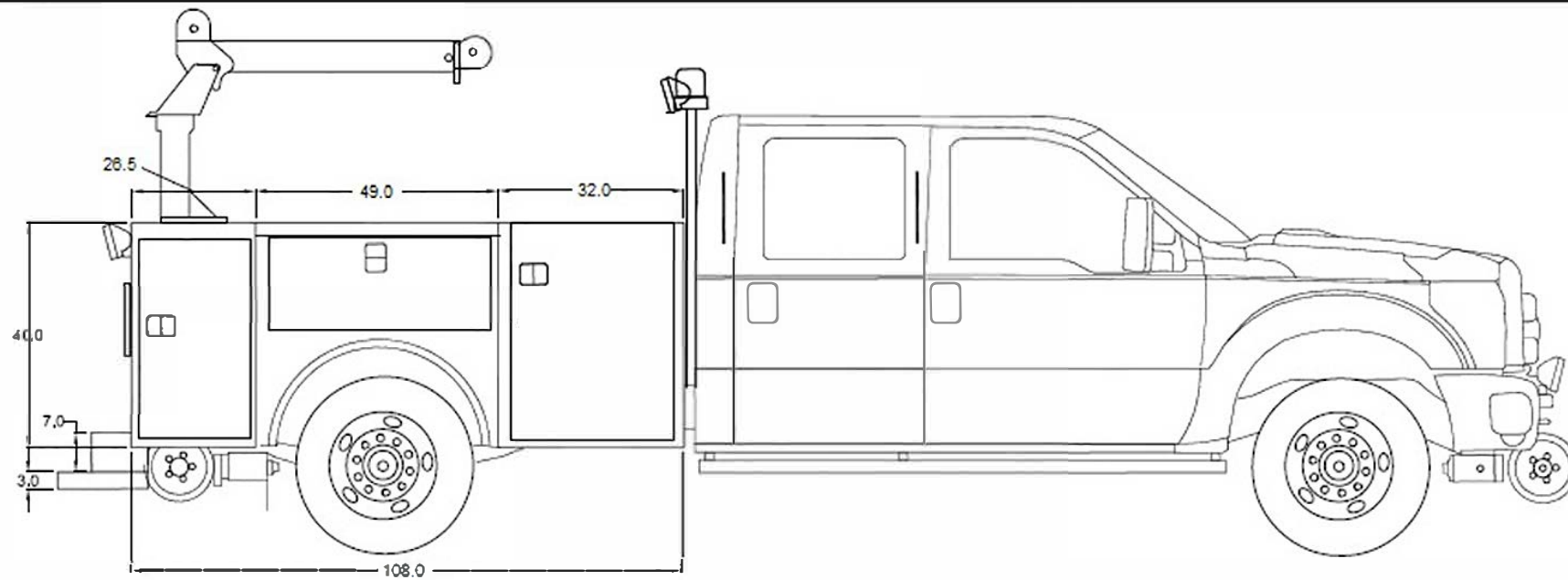
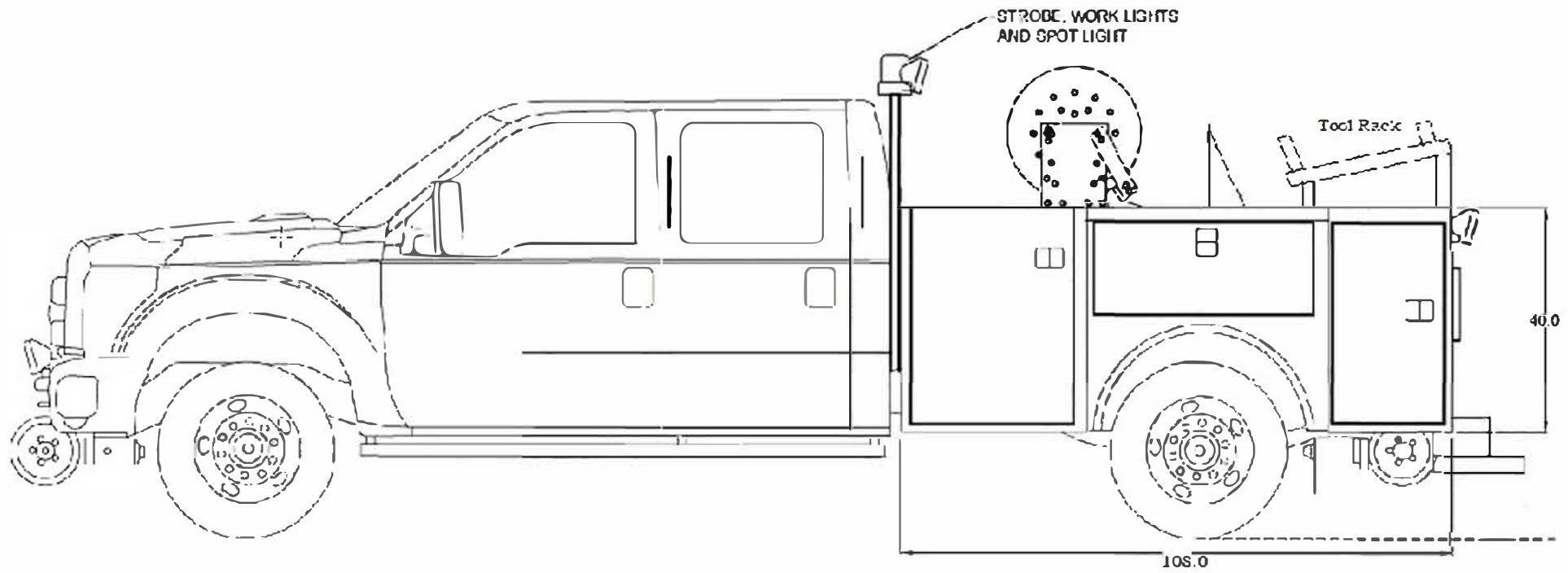

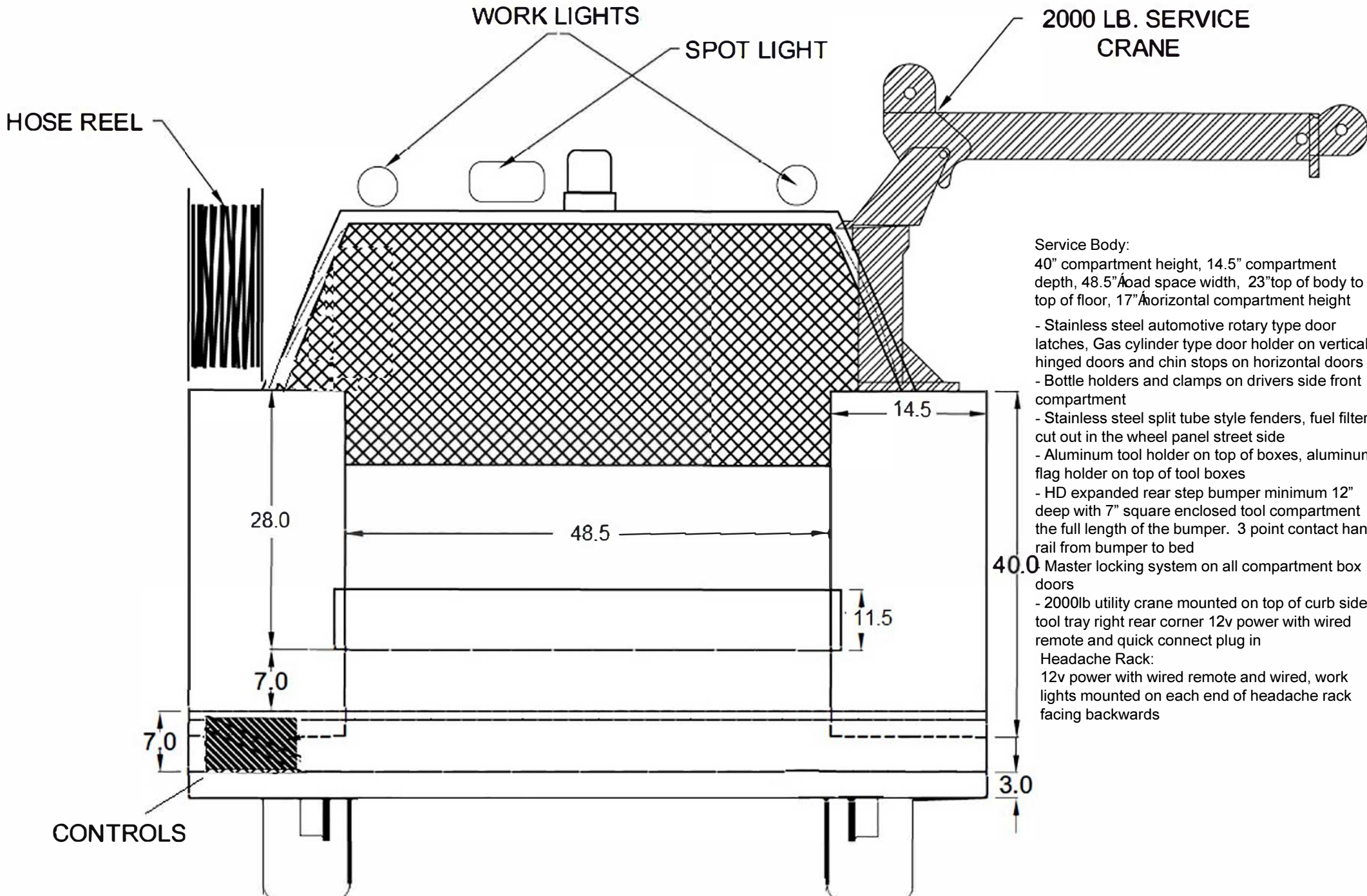

- Hose reel 50ft 1/2" arctic grade: Hose reel is for Hydraulic Tool circuit:
Chassis engine driven hydraulic tool circuit w/ valves & self-winding (25' length - Stanley recommendation for hose diameter & manufacturer) hose reel mounted on drivers side rear on top of tool boxes. Hydraulic specs: 10gpm@2,000 psi & 5gpm at 2,000 psi continues with a twin line hose
